STANDARD FORM: AGREEMENT

This agreement, made on the 19th day of March, 2024 between the Governor of Haryana, acting through Executive Engineer, M.Garh Canal Water Services Division, Mahendergarh (hereinafter called "the Engineer" which expression shall, unless the Contract otherwise requires, be deemed to include his successors and assigns) on the one part "Shubham Contractor, Ward No. 2, Aadarsh Colony, Mahendergarh -123029" (hereinafter called the Contractor" which expression shall unless the Contract otherwise requires, be deemed to include his successors and assigns) of the other part.

Whereas the Employer is desirous that the Contractor execute the work "Estimate of Laying RCC pipeline for connecting village pond Israna off taking from 10.700/R of Nangal disty.(Under Atal Bhujal Yojna)" costing Rs. 17,79,905/- (Rs. Seventeen lacs Seventy Nine thousand Nine hundred five only) completion period is 04 Months Agreement No. 340 /2023-2024 (hereinafter called "the works") and the Engineer has accepted the Bid by the Contractor for the execution and completion of such works and the removal/remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract.

The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and remedying the defects within the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

- ii) Notice to Proceed with the works;
- iii) Contractor's Bid;
- iv) Contract Data;
- v) Special Conditions of Contract and General Conditions of Contract;

- viii) Bill of Quantities; and
- ix) Any other document listed in the Contract Data as forming part of the Contract.
