## STANDARD FORM: AGREEMENT

This agreement, made on the 26th day of February, 2024 between the Governor of Haryana, acting through Executive Engineer, M.Garh Canal Water Services Division, Mahendergarh (hereinafter called "the Engineer" which expression shall, unless the Contract otherwise requires, be deemed to include his successors and assigns) on the one part "R.K Concrete Udyog Near Water Works Satroad Khas, Hisar-125044" (hereinafter called the Contractor" which expression shall unless the Contract otherwise requires, be deemed to include his successors and assigns) of the other part.

Whereas the Employer is desirous that the Contractor execute the work "Laying RCC pipeline for connecting Village Pond Meghanwas from Km. 1.400/R of Bucholi Disty. and Excavation of Pond (under Atal Bhujal Yojana)" costing Rs. 24,31,957/- (Rs. Twenty four Lakhs thirty One Thousand Nine Hundred Fifty Seven only) completion period is 04 Months Agreement No. 328 /2023-2024 (hereinafter called "the works") and the Engineer has accepted the Bid by the Contractor for the execution and completion of such works and the removal/remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH as follows:

- In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract.
- The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and remedying the defects within the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
