## STANDARD FORM: AGREEMENT

This agreement, made on the 13<sup>th</sup> day of December, 2023 between the Governor of Haryana, acting through Executive Engineer, M.Garh Canal Water Services Division, Mahendergarh (hereinafter called "the Engineer" which expression shall, unless the Contract otherwise requires, be deemed to include his successors and assigns) on the one part "The Natraj Co Op L and C Society Ltd., H. No. 4935, Sec-10, Jind-126102" (hereinafter called the Contractor" which expression shall unless the Contract otherwise requires, be deemed to include his successors and assigns) of the other part.

Whereas the Employer is desirous that the Contractor execute the work "Laying RCC pipeline for connecting village pond Kheri(Bani Wala Pond) off taking from km. 6.400/R (amended RD 6.927) of Bassai Disty.(Under Atal Bhujal Yojna)" costing Rs. 12,09,509.00 (Twelve Lakhs Nine Thousand Five Hundred Nine Only) completion period is 04 Months Agreement No. 306 /2023-2024 (hereinafter called "the works") and the Engineer has accepted the Bid by the Contractor for the execution and completion of such works and the removal/remedying of any defects therein.
