STANDARD FORM: AGREEMENT

This agreement, made on the 04TH day of December, 2023 between the Governor of Haryana, acting through Executive Engineer, M.Garh Canal Water Services Division, Mahendergarh (hereinafter called "the Engineer" which expression shall, unless the Contract otherwise requires, be deemed to include his successors and assigns) on the one part "The Basti Ram Co-Operative Land C Society Ltd. Village - Bagthala, Tehsil - Bawal, Rewari - 123501" (hereinafter called the Contractor" which expression shall unless the Contract otherwise requires, be deemed to include his successors and assigns) of the other part.

Whereas the Employer is desirous that the Contractor execute the work "Laying RCC pipeline for village pond of Lawan off-taking from km. 6.004/L of Lawan Disty. and for village pond of Jant off-taking from km. 6.240/R of Lawan Disty.(Under Atal Bhujal Yojana)" costing Rs. 34,01,694/- (Rs. Thirty Four lacs one thousand six hundred Ninety four only) completion period is 06 Months Agreement No. 301 /2023-2024 (hereinafter called "the works") and the Engineer has accepted the Bid by the Contractor for the execution and completion of such works and the removal/remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH as follows:

2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract.

3. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and remedying the defects within the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
