This agreement, made on the 14th day of December, 2023 between the Governor of Haryana, acting through <u>Executive Engineer</u>, M.Garh Canal <u>Water Services Division</u>, Mahendergarh (hereinafter called "the Engineer" which expression shall, unless the Contract otherwise requires, be deemed to include his successors and assigns) on the one part <u>Eshree Balaji Builders</u>, <u>858</u>, Sector- 23, Bhiwani (Haryana)- 127021" (hereinafter called the Contractor" which expression shall unless the Contract otherwise requires, be deemed to include his successors and assigns) of the other part.

Whereas the Employer is desirous that the Contractor execute the work "Laying pressurized pipeline for connecting various ponds in village Duloth including the construction of Pump House, Pumping Machinery and other allied works including running and maintenance for three years" costing Rs. 8,15,68,165.00 (Eight Crore Fifteen Lakhs Sixty Eight Thousand One hundred Sixty Five Only) completion period is 09 Months Agreement No. 307 /2023-2024 (hereinafter called "the works") and the Engineer has accepted the Bid by the Contractor for the execution and completion of such works and the removal/remedying of any defects therein.
