AGREEMENT DEED

This agreement, made on the06... day of March 2023.. between the Governor of Haryana, acting through Executive Engineer, M/Garh Canal Water Services Division, Narnaul of the one part and M/s Dhareswar Borewell [name and address of Contractor] (hereinafter called "the Contractor" which expression shall unless the Contract otherwise requires, be deemed to include his successors and assigns) of the other part.

Whereas the Engineer is desirous that the Contractor executes "Recharging ground watertable from surplus water during rainy season by installing injection wells or suitable structure at 25 different locations in Ateli Block Distt Mohindergarh." for amounting to Rs. 79,26,470/- only and the Engineer has accepted the Bid by the Contractor for the execution and completion of such works and the removal/ remedying of any defects therein.
