AGREEMENT DEED

No 249 dated 14-03-2024

This agreement, made on the **14.03.2024** between the Governor of Haryana, acting through **Executive Engineer, Loharu Water Services Division, Charkhi Dadri** (Hereinafter Called "the Engineer" which expression shall, unless the Contract otherwise requires, be deemed to include his successors and assigns) of the one part and **M/s Bala Ji Enterprises, VO Kharkara, Tehsil Hansi, District Hisar** hereinafter called "the Contractor" which expression shall unless the Contract otherwise requires, be deemed to include his successors and assigns) as the other part.

Whereas the Engineer is desirous that the Contractor execution of work "**Laying underground RCC pipeline 350mm dia NP3 to recharge 3 Nos. recharge well in Mandi Hariya village**" amounting **Rs.2366632/- (Twenty three lacs six thousand six hundred thirty two only)** (name and identification number of Contractor) (Hereinafter called "the works") and the Engineer has accepted the Bid by the Contractor for the execution and completion of such works within **3 months i.e. 13.06.2024** and the removal/remedying of any defects therein.

NOW, THEREFORE, THIS AGREEMENT WITNESSETH as follows: -

1. In this agreement, words and expression shall have the same meanings as are respectively assigned to them in the following documents: -

 - c. Conditions of Contract (Section-3)
 - d. Special Conditions of Contract (Section-4)

- i. Documents to be furnished by bidder

All of which are hereinafter referred to, as the "Contract", and they shall be deemed to form and be read and construed as part of this Agreement.

2. In consideration of the payments to be made by the Engineer to the Contractor as herein mentioned, the Contractor hereby covenants with the Engineer to execute and complete Works and rectify defects therein in conformity in all respects with the provisions of Contract.
3. The Engineer hereby covenants to pay the Contractor in consideration of the execution completion of the works in all respect in the Contract Price or such other sum as they because payable under the provision of the Contract at the times and in the manner prescribed by Contract.
